COMMUNICATION IN A CRISIS

During a crisis, such as a pandemic, communication is key. The goal of our Marketing/Communications (MarCom) Department was to keep the community aware of our plans and the adjustments we were making. This involved three separate groups: our donors, our shoppers, and our program participants.

Once decisions were made by Goodwill of Central Illinois administration and our Board of Directors, the communication began. Our most effective tools were our website and social media. We operate both Facebook and Instagram pages. As with all of our social media and website posts, we keep the information concise but creative.

While stores were closed by an Illinois executive order, we continued to accept donations. This was done by simply making donation boxes available outside of our donation doors. This proved beneficial as over a 70-day period donations increased by 15%.

THE SHOW MUST GO ON

The truth is, we probably saw too much of it on TV and social media, but the pandemic gripped our world unlike anything before. As with TV and social media, communication about COVID-19 was the order of the day. Communication was our first step with participants, partners, and each other.

First, we had to spread the word about how we planned to handle the state-wide shut down and that we would continue our services, but they would become virtual.

Once our participants and partners knew our plan, we had to decide how things would operate internally. We knew that, again, communication was the key. That's when we invested in Microsoft Teams. This format would allow us to be in constant communication with each other as well as the community we serve.

Virtual communication comes with a big learning curve, and it took time for all of us to get the hang of it. Eventually the "stay-at-home order" was lifted, and we returned to the office. But the pandemic continued, and we continued to serve the community virtually. Job coaching, computer classes, resume building, even forklift operation training all became virtual.

The year is now 2021, and we are slowly getting back to normal, but that is a story for another annual report.

SUCCEEDING THROUGH ADVERSITY

March 2020 began a challenge like the world had never seen. While the true struggle was life and death, we all still had jobs and the pandemic threatened our livelihood. Goodwill, like millions of other businesses, faced uncertainty. With a "stay-at-home order" beginning, we faced the possibility that the business would not survive. Our source of income, our stores, were closed and would be for the next 70 days.

The people of Central Illinois showed their generosity as donations poured in during the shutdown, but with stores closed there was no one to buy them. The only way to move merchandise was through Shopgoodwill. Under normal circumstances stores provide our Shopgoodwill department with items, and they list them. However, with a major cut in manpower, the individual stores would now have to take over.

With a skeleton crew in each store, the teams would have to learn how to value, post, and sell on Shopgoodwill. Each store knew the importance of what they were doing and accepted the challenge head on. For the month of May 2020, Goodwill of Central Illinois' Shopgoodwill total was nearly \$117,000. This was, by far, the most profitable month of the entire year. Working together, our 11 stores were able to post 8,404 items!

This success was a testament to teamwork. It was about our employees taking pride in Goodwill, our mission, and each other.
